### 2013 PIT-EXT - Personal Income Tax Extension Payment Voucher

**Purpose of this form.** Use the 2013 PIT-EXT payment voucher to make an extension payment towards a 2013 personal income tax liability. An extension payment is made when either a federal automatic extension has been obtained or a New Mexico extension has been obtained, and a payment towards the tax liability is made to avoid the accrual of interest. By obtaining an extension of time to file your return, penalty for failure to file and pay is waived through the extension period, provided you file the return and pay the tax shown on the return by the extended due date. Interest accrues even if you obtain an extension of time to file and pay the return. Interest is assessed daily at the quarterly rate established for individuals by the U.S. Internal Revenue Code on the amount of tax due. Annual and daily interest rates for each quarter are posted on the Department website at <a href="https://www.tax.newmexico.gov">www.tax.newmexico.gov</a>.

If you expect to owe tax when you file your 2013 return, make a payment using the 2013 PIT-EXT payment voucher to avoid the accrual of interest on the principal tax due. Submit the bottom portion of this page with the check or money order.

#### About the Application for Extension of Time to File.

- Federal automatic extension filed. New Mexico recognizes and accepts an Internal Revenue Service automatic extension of time
  to file. If you have obtained the federal automatic extension by filing Form 4868, Application for Automatic Extension of Time To File
  a U.S. Individual Income Tax Return for tax year 2013, you have the federal automatic extension period allowed by the IRS (through
  October 15, 2014 for most calendar year filers) to file your New Mexico return. You do not need to file New Mexico Form RPD-41096,
  Application for Extension of Time to File. Detach the bottom portion of this document and submit it to the Department with your payment.
- New Mexico extension request filed. If you expect to file your federal return by the original due date or by the six-month automatic extension of time to file allowed by the IRS, but need additional time to file your New Mexico return, you must obtain approval through the state. To request approval, you must submit Form RPD-41096, *Application for Extension of Time to File*, on or before the due date of the return or the extended due date of the return. You may submit RPD-41096 at the same time you submit your extension payment. Detach the bottom portion of this document and submit it to the Department with your extension payment.

You may submit payment with the payment voucher below or pay online at no charge by electronic check. To pay online, go to the Taxation and Revenue Department website at <a href="www.tax.newmexico.gov">www.tax.newmexico.gov</a> and click **Online Services**. The electronic check authorizes the Department to debit your checking account in the amount and on the date you specify. You may also use any of these credit cards—Visa, MasterCard, American Express, or Discover Card—for your online payment. A convenience fee of 2.40% is applied for using a credit card. The State of New Mexico uses this fee, calculated on the transaction amount, to pay charges from the credit card companies. To file a New Mexico application for extension of time to file and pay, you must submit Form RPD-41096.

**NOTE:** When you provide a check as payment, you authorize the Department either to use information from your check to make a one-time electronic fund transfer from your account, or to process the payment as a check transaction.

## 2013 PIT-EXT, Extension Payment Voucher, Checklist

Are name(s) and address complete, correct and legible?
Are social security number(s) legible?
Are social security number(s), "PIT-EXT", and the correct tax year written on your check?
Did you select the PIT-EXT for the correct tax year for which you are making the payment?
Did you mail your PIT-EXT and check to the address on the payment voucher?
Did you sign and include your check?
Have you attached Form RPD-41096, <i>Application for Extension of Time to File</i> , or otherwise submitted a timely request for a New Mexico extension? This form can be downloaded from TRD's web site at <a href="https://www.tax.newmexico.gov">www.tax.newmexico.gov</a> , select "Forms and Publications". If you obtained a federal automatic extension, you do not need to file Form RPD-41096 unless the requested extension period extends beyond the time allowed by the federal automatic extension.

- ☐ Are you using the correct form?
  - Form 2013 PIT-EXT, Extension Payment Voucher, is used by taxpayers who have obtained a federal automatic extension or a New Mexico extension, who expect to owe tax on the 2013 PIT-1 return and wish to make a payment towards the liability to avoid the accrual of interest.
  - **Form PIT-PV,** *Return Payment Voucher,* is used by taxpayers when making a payment towards a 2013 PIT-1 return that has been filed or is filed at the time the payment is made.
  - Form PIT-ES, Estimated Payment Voucher, is used by taxpayers making an estimated payment towards the current year tax liability.

SUBMIT ONLY HIGH-QUALITY PRINTED, ORIGINAL FORMS TO THE DEPARTMENT. Do not photocopy. When printing the document from the Internet or a software product, the printer setting, "Page scaling" should be set to 'none' to prevent resizing. The payment vouchers are processed through high-speed scanners and a quality form ensures your payment is processed accurately. Do not cut the bottom portion of the voucher except where indicated--cut on the dotted line only. If your voucher has a scanline, do not write in the area around the scanline. The scanline is located within the bottom 1-1/2 inch of the voucher. The Department receives a large amount of payment vouchers WITHOUT the check or money order. Please ensure you submit the payment with the payment voucher.
