What is Form ND-1V?

Form ND-1V is a form you complete and send in with a check or money order to pay a balance due on an electronically filed North Dakota individual income tax return. You may also pay a balance due electronically see "Electronic payment option."

Do not use Form ND-1V to make an extension payment. Extension payments should be made using the extension payment voucher, Form ND-1EXT.

When is the payment due?

The payment must be made on or before April 15, 2016, to avoid any late payment penalty or interest. This applies even if you have not received acknowledgement that your electronic North Dakota return was accepted.

How to make payment

If paying by check or money order, make the check or money order payable to "ND State Tax Commissioner," and write last four digits of social security number and "2015 ND-1V" on check or money order. Complete the payment voucher, detach it from this page, and mail it with the check or money order to:

Office of State Tax Commissioner PO Box 5622 Bismarck, ND 58506-5622 Only a check drawn on a U.S. or Canadian bank in U.S. dollars and using a standard 9-digit routing number is accepted.

Electronic payment option. Instead of paying by check or money order with this payment voucher, the payment may be made online with a debit or credit card or electronic check. North Dakota contracts with a national payment service to provide this option. There is a fee for this service, none of which goes to the State of North Dakota. *If paying electronically, do not use this voucher.*
