3. Click the "Print" button to print a completed 525 TV Individual/Fiduciary payment voucher.
4. Cut the payment voucher along the dotted line and mail the voucher and your payment only to the address on the voucher.

DO NOT mail in the worksheet, keep this for your records.

- For faster and more accurate posting to your account, use a payment voucher with a **valid scanline** from Georgia Department of Revenue's website www.dor.ga.gov/forms.aspx or one produced by an approved software company listed at www.dor.ga.gov/IndTax_TSD.aspx
- Only complete this voucher if you owe taxes.
- Complete the name and address field located on the upper right side of the voucher.
- Please write your SSN or FEIN on your check or money order.
- Remove your check stub to keep with your records.

If you are **filing electronically**,
mail only your voucher and payment to:

If you are filing a paper return; mail your return , 525 TV payment voucher and your payment to the address that appears on the return.
