HAWAII S CORPORATION
AGREEMENT OF NONRESIDENT SHAREHOLDER

This agreement is to be attached to the S corporation's return for the first year
which the corporation is subject to the provisions of section 235-128(c), Hawaii
Revised Statutes, with respect to the nonresident shareholder.

Section 235-128(c), Hawaii Revised Statutes, requires S corporations to timely file this agreement for each nonresident shareholder or to pay to the State an amount equal to the nonresident shareholder's pro rata share of the S corporation's income attributable to Hawaii multiplied by the highest marginal income tax rate for individuals. The S corporation is entitled to recover from a shareholder any such payment made on behalf of the shareholder.

If the shares of the S corporation are jointly owned, each owner must execute a separate agreement.
