

Purpose

If you are applying for an extension of time to file your 2011 North Dakota individual income tax return, you may make an extension payment to prepay the tax that you expect to owe to avoid paying extension interest.

If you make an extension payment, you must file Form ND-1 and claim the payment on page 2, line 29; you may not file Form ND-EZ.

You may pay by check or credit card—see the separate instructions on this page for the payment procedures under each method. Regardless of how you choose to make the payment, it must be made no later than April 15, 2012, to avoid extension interest.

Important. Do not use the voucher below if you:

- Choose to make the extension payment by credit card,
- File your return on or before April 15, 2012, or
- Pay your balance due after April 15, 2012.

Any tax due with your return is subject to extension interest.

To pay by check

Complete the voucher below and mail it with your check (or money order) to:

When filling out the voucher:

- Make sure your social security number is correct. We need it to properly credit your account.
- Enter your spouse's social security number if you plan to file a joint return.

Be sure to include the amount of your payment on Form ND-1, line 29.

To pay by credit card

If you choose to pay by credit card, do **not** use the voucher below.

You may make your extension payment using your MasterCard®, American Express® Card, Discover® Card, or VISA® Card.

Credit card payments must be made by telephone or over the Internet through Link2Gov Corporation, a private credit card payment service provider. A fee will be charged to your credit card by Link2Gov Corporation, which is retained by the provider for its services—the State of North Dakota does not receive any part of the fee.

To make your extension payment by credit card, go to Link2Gov Corporation's web site at **www.ndtaxpayment.com** or call them toll free at 1-888-ND-TAXES (1-888-638-2937).

Be sure to include the amount of your payment on Form ND-1, line 29.
