

**PLEASE READ INSTRUCTIONS FOR REV-426
PA CORPORATION SPECIALTY TAXES EXTENSION COUPON**

NOTE: Beginning tax year 2011, there is only one coupon (REV-426) for requesting a specialty tax filing extension. You must timely file REV-426 even if you are not making a payment with the extension request.

- Enter account information** including file period begin, file period end, tax account ID, due date, EIN, entity name and complete mailing address.
- Signature, title, date, email address and telephone number** must be provided by a representative of the entity.
- Make check** payable to "PA Department of Revenue". Mail the check and coupon to:

Do not use this coupon if an extension request with payment is being made electronically.

- Enter payment(s) required** for the appropriate tax type(s) from the list below. Find the four-digit code next to the appropriate tax type and enter it in one of the three boxes to the right. The code will populate into the tax type box on the attached coupon. You may request an extension and pay up to three tax types with this coupon, using only one code per box. Be careful when making your selections(s) to ensure your extension and payment is applied to the correct tax type.
