## **GENERAL INSTRUCTIONS:**

#### **SPECIAL INSTRUCTIONS FOR LINE 9:**

If this schedule is not attached to your return **or** if the amount in Box 10 is not entered on your return, your contribution will not be recognized and the amount will be refunded to you.
