## Federal Changes (including net operating loss (NOL) deductions)

#### If you file Form IL-1040-X because you filed a U.S. Form 1040X or Form 1045 that resulted in

an overpayment or because you are claiming an NOL carryback deduction, you must wait to file this form until you receive a federal finalization notice from the IRS stating that they have accepted your change either by paying a refund or by final assessment, agreement, or judgment. Write the date the IRS notified you (not the date you filed your U.S. Form 1040X or Form 1045) in the appropriate space in Step 1, Line F, and attach proof of federal finalization.

**Proof of federal finalization for U.S. 1040X or Form 1045 overpayments and NOL carryback deductions** includes a copy of the notification you received from the IRS that they accepted your changes; *e.g.*, a refund check, "Statement of Account," agreement, or judgment, **and** 

- a copy of your U.S. Form 1040X, if filed, or
- a copy of your U.S. Form 1045, Application for Tentative Refund, including all pages of Schedules A and B, along with a copy of your refund check, if you filed your federal amended return due to an NOL.
- a balance due, you must attach proof of federal finalization and write the date you filed your U.S. Form 1040X and paid the tax due in the appropriate space in Step 1, Line F. Failure to provide this date could result in an assessment of a latepayment penalty.

**Proof of federal finalization for U.S. 1040X underpayments** is a copy of your U.S. Form 1040X and a copy of the check you sent to the IRS to pay the tax due.


