Form RI-1065V is a statement you send with your payment of any balance due on line 14 from Form RI-1065. Using Form RI-1065V allows us to more accurately and efficiently process your payment. We strongly encourage you to use Form RI-1065V, but there is no penalty for not doing so.

#### HOW TO FILL IN FORM RI-1065V

- Enter the name and addresses as shown on your return.
- Enter the federal employer identification number in the box provided.
- Enter the calendar year or the fiscal year beginning and ending dates.
- Enter the amount of the payment being made.
- Have authorized officer or agent sign form.
