- For faster and more accurate posting to your account, use a payment voucher with a **valid scanline** from Georgia Department of Revenue's website https://etax.dor.ga.gov/forms.aspx or one produced by an approved software company listed at https://etax.dor.ga.gov/inctax/efile/corp_efile_info.aspx
- Only complete this voucher if you owe taxes.
- Complete the name and address field located on the voucher.
- Please write your FEIN on your check or money order.
- Remove your check stub to keep with your records.
- Mail only your voucher and payment to:
