Form PCR Instructions for 2013, Cont.

If You Owe Federal or Minnesota Tax

—or if you owe criminal fines, a debt to a state or county agency, district court, qualifying hospital or public library, state law requires the department to apply your refund to the amount you owe (including penalty and interest on the taxes).

If your debt is less than your refund, you will receive the difference.

Use of Information

Form PCR is not required by law to be filed. However, to claim a political contribution refund, you must file this form. All information on this form is required to properly identify you and determine if you qualify for this refund. Your Social Security number is required by M.S. 270C.306. If all the information, other than your phone number and banking information, is not provided, your application may be delayed or denied.

Your Social Security number and all other information on Form PCR are private and cannot be disclosed to others without your consent. However, your contribution can be tabulated with those of other contributors to that candidate or political party, and the total can be given to the Campaign Finance and Public Disclosure Board.
