Partnership Extension Payment

Purpose

58-EXT

If a partnership is applying for an extension of time to file the 2013 Form 58, it may prepay the tax that is expected to be due on it to avoid paying extension interest. The payment must be made no later than the 15th day of the 4th month following the end of the tax year.

Important: Do not use this extension payment voucher if:

- The 2013 Form 58 is filed on or before the due date (without extension).
- The tax balance due is going to be paid after the due date (without extension) of the 2013 Form 58.
- The payment will be made electronically—see "How to make payment" for payment options.

Any tax due with the return is subject to extension interest.

How to make payment

If paying by paper check or money order, make the check or money order payable to "ND State Tax Commissioner." Complete the payment voucher below, detach it from this page, and mail it with the paper check or money order to:

Electronic payment option. Instead of submitting a paper check or money order with this payment voucher, the balance due may be paid electronically through an Automated Clearing House (ACH) credit transaction or online through Link2Gov Corporation, a national electronic payment service. If paying electronically, do not use the paper voucher below.

To pay by means of an ACH transaction, go to www.nd.gov/tax and click on "S Corp and Partnership" on the left-hand side of the page. Then click on "Electronic Payment."

To pay online through Link2Gov

Corporation, go to www.ndtaxpayment.com. Link2Gov charges a fee for its service, none of which goes to the State of North Dakota. The amount of the fee will be provided during the transaction with an option to continue or cancel the transaction.
