1.	I. To be considered in the auction, a bid must be submitted online between 9 a.m., October 13, 2014 and 5 p.m. PDT, October 22, 2014 and a completed Form TCA with your payment must be received in a Department of Revenue office by 5 p.m. PDT, October 29, 2014. Postmarks will not be considered and we can't guarantee that any mailed payments will be received by the deadline.							
2.	Bank-issued cashier's checks, bank-issued certified checks, or money orders made payable to Oregon Department of Revenue are the only acceptable forms of payment. Personal checks, credit cards, wire transfers, and cash will not be accepted and your bid will not be considered.							
3.	3. Once a bid is submitted, it cannot be changed or revoked.							
4.	1. A bidder may submit multiple bids. A separate payment and Form TCA must be completed for each bid.							
5.	5. We will issue up to 4,065 tax credit certificates (each worth \$500) to the highest qualifying bids. The credits are non-transferable. The credit can be claimed on your 2014 tax return. Any amount that cannot be used on your 2014 tax return can be carried forward for up to 3 years. Tax credit certificates will be mailed to the prevailing bids at the address listed on this form.							
6.	5. If the associated bid does not result in the issuance of a tax credit certificate, payment will be returned to the bidder at the address listed on this form.							
7.	If there is a tie, the tax credit certificate will be issued to the bid received first. It is possible that a bidder may receive fewer certificates than bid.

Bidding instructions for Form TCA

Oregon Tax Credit Auction

Bidding steps

- 1. Go to www.oregon.gov/dor/pertax/pages/credit-auction-info.aspx between 9 a.m., October 13, 2014, and 5 p.m. PDT, October 22, 2014 to submit your bid. Keep a copy of the online confirmation for your records.
- 2. Complete Form TCA (this form) for each bid you submit. Read the auction rules carefully. Sign the form to acknowledge that you understand and agree to the rules.
- 3. Obtain payment (certified check, cashier's check, or money order made payable to Oregon Department of Revenue) for the full amount of the bid (see "Payments" below).
- 4. Deliver the payment and a completed Form TCA to us by 5 p.m. PDT, October 29, 2014.

Deadlines

The auction bidding and payment deadlines will be strictly enforced. Please take care to ensure that both the bidding and payment deadlines are met. Payments may be personally delivered to any Department of Revenue office. **Warning!** If you mail your payment and Form TCA to the Department of Revenue, make sure you:

- Mail it early enough to ensure it's received by October 29, 2014; and
- Send it to the address below to ensure it receives expedited treatment. **Remember, postmarks do not count.**

Payments

We will only accept bank-issued certified checks, bank-issued cashier's checks, or money orders made payable to Oregon Department of Revenue as valid forms of payment. Cash, personal checks, and wire transfers are not acceptable forms of payment. They will be returned to you and your bid will not be considered in the auction.

If your bid is not successful, we'll return your payment to the address on Form TCA (please verify that your return address is correct).

Please verify the procedures and possible fees that you may be charged to cancel your payment if it is returned to you. If you're using a money order, we recommend that you use the U.S. Postal Service because the USPS can easily re-issue the money order.
