NOTE: Effective January 1, 2012, civil unions are recognized in Hawaii (Act 1, Session Laws of Hawaii 2011). Effective December 2, 2013, same sex marriages are recognized in Hawaii (Act 1, Second Special Sessions Laws of Hawaii 2013). Hawaii laws recognize marriages between individuals of the same-sex, and extends to such same-sex couples the same rights, benefits, protections, and responsibilities of marriage that opposite-sex couples receive.
