To be considered in the auction, a bid must be submitted online between 9 a.m., July 11, 2016 and 5 p.m. PDT, July 15, 2016 and a completed Form OR-TCA with your payment must be received in a Department of Revenue office by 5 p.m. PDT, July 22, 2016. Postmarks won't be considered and we can't guarantee that any mailed payments will be received by the deadline.				
2.	2. Bank-issued cashier's checks, bank-issued certified checks, or money orders made payable to Oregon Department of Revenue are the only acceptable forms of payment. Personal checks, credit cards, wire transfers, and cash won't be accepted and your bid won't be considered.				
3.	3. Once a bid is submitted, it can't be changed or revoked.				
4.	4. A bidder may submit multiple bids. A separate payment and Form OR-TCA must be completed for each bid.				
5.	5. We will issue up to 24,000 tax credit certificates (each worth \$500) to the highest qualifying bids. The credits are non-transferable. The credit can be claimed on your 2016 tax return. Any amount that cannot be used on your 2016 tax return can be carried forward for up to 3 years. Tax credit certificates will be mailed to the prevailing bids at the address listed on this form.

Bidding instructions for Form OR-TCA

Oregon tax credit auction

Bidding steps

- 1. Go to www.oregon.gov/dor and search, "Tax credit auction," between 9 a.m., July 11, 2016, and 5 p.m. PDT, July 15, 2016 to submit your bid. Keep a copy of the online confirmation for your records.
- 2. Complete Form OR-TCA (this form) for each bid you submit. Read the auction rules carefully. Sign the form to acknowledge that you understand and agree to the rules.
- 3. Obtain payment (certified check, cashier's check, or money order made payable to Oregon Department of Revenue) for the full amount of the bid (see "Payments" below).
- 4. Deliver the payment and a completed Form OR-TCA to us by 5 p.m. PDT, July 22, 2016.

Deadlines

The auction bidding and payment deadlines will be strictly enforced. Take care to ensure that both the bidding and payment deadlines are met. Payments may be personally delivered to any Department of Revenue office. **Warning!** If you mail your payment and Form OR-TCA to the Department of Revenue, make sure you:

- Mail it early enough to ensure it's received by July 22, 2016; and
- Send it to the address below to ensure it receives expedited treatment. **Remember, postmarks don't count.**

Payments

We will only accept bank-issued certified checks, bank-issued cashier's checks, or money orders made payable to Oregon Department of Revenue as valid forms of payment. Cash, personal checks, and wire transfers are not acceptable forms of payment. They will be returned to you and your bid won't be considered in the auction.

If your bid isn't successful, we'll return your payment to the address on Form OR-TCA (please verify that your return address is correct).

Please verify your banking institution's procedures and possible fees to cancel your payment if it's returned to you. If you're using a money order, we recommend that you use the U.S. Postal Service because USPS can easily re-issue the money order.
