Form HS-122 Due Date - April 18, 2016. Homeowners filing a property tax adjustment, Forms HS-122 and HI-144, between April 19 and Oct. 17, 2016 may still qualify for a property tax adjustment. A \$15 late filing fee will be deducted from the adjustment.

Annual Vermont Homestead Declaration

SECTION A.

This form must be filed each year by every Vermont resident whose property meets the definition of a homestead. A Vermont homestead is the principal dwelling and parcel of land surrounding the dwelling, owned and occupied by a resident individual as the individual's domicile on April 1. If your homestead is leased to a tenant on April 1, you may still claim it as a homestead if it is not leased for more than 182 days in the 2016 calendar year.
