Filling in Your Return Use black ink to complete the form. Round off cents to the nearest dollar. Drop amounts under  $50\phi$  and increase amounts from  $50\phi$  through  $99\phi$  to the next dollar. If completing the form by hand, do not use commas when filling in amounts.

**Line 2 Dependents** Check line 2 if your parent (or someone else) can claim you (or your spouse) as a dependent on his or her return. Check line 2 even if that person chose not to claim you.

Line 3 If you checked line 2, use this worksheet to figure the amount to fill in on line 3.

Lines 17 - 21 If this is an amended return, see the instructions for lines 33 - 37 of Form 1A.

Line 22 – If line 15 is more than line 20, subtract line 20 from line 15.
