Failure to timely submit required documentation will result in denial of the related credit. Revenue Online e-Filer Attachment provides you with a confirmation number and will be available to the Department immediately.

Otherwise, complete this form, package it with your documentation and mail to the Department. Using this form can extend return processing time up to 6 weeks.
