## Purpose

If you are applying for an extension of time to file the 2019 Form 38, you may make an extension payment to prepay the tax that is expected to be due to avoid paying extension interest. The payment must be made no later than the due date of the return (without extension).

### Important.

 Do not use this voucher if:

- The 2019 Form 38 is filed on or before the due date of the return (without extension).
- Any tax due on the 2019 Form 38 is going to be paid after the due date (without extension).
- The payment will be made electronically—see “How to make payment” for payment options.

If the 2019 Form 38 is filed after its due date (without extension), any tax paid with the return is subject to extension interest.

## How to make payment

If paying by check or money order, make it payable to “ND State Tax Commissioner” and write last four digits of federal employer

identification number (FEIN) and “2019 38-EXT” on it. Complete the payment voucher below, detach it from this page, and mail it with the check or money order to:

Only a check drawn on a U.S. or Canadian bank in U.S. dollars and using a standard 9-digit routing number is accepted.

**Electronic payment options.** Instead of paying by check or money order with this payment voucher, the payment may be made electronically in one of the two ways. *If paying electronically, do not use this voucher.*

- **Online**—Pay online with an electronic check or a debit or credit card. The electronic check option is free. North Dakota contracts with a national payment service to provide the debit or credit card option, for which there is a fee, none of which goes to the State of North Dakota. To pay online, go to [www.nd.gov/tax/payment](http://www.nd.gov/tax/payment).

- **Electronic funds transfer**—A payment may be made by means of an Automated Clearing House (ACH) credit transaction that the taxpayer initiates through its banking institution. For more information, go to our website at [www.nd.gov/tax](http://www.nd.gov/tax).
