**NOTE**: If Line 33 is less than \$246, the estate or trust generally does not have to make estimated tax payments.

**CAUTION**: If Line 33 is less than \$246, the estate or trust may still be subject to estimated underpayment penalties if the estate or trust's tax liability for 2019 after payments and credits is more than \$246. If the estate or trust has unexpected income or income grows to an amount in excess of \$8,000 with no payments or credits being scheduled for the tax year, the estate or trust should immediately file an amended declaration and make estimated tax payments accordingly.

NOTE. The department will apply the credit from the 2018 PA-41 form as of the due date of the 2018 PA-41 form. If the 2018 credit is greater than the first 2019 installment payment, it is not necessary to file the first estimated form. The department does not require a 2019 estimated form until you must make a PA PIT estimated installment payment on behalf of the estate or trust.
