INSTRUCTIONS

File and pay online at MyDORWAY.dor.sc.gov. Do not mail this form when filing online.

Due dates: First Quarter (Jan - Mar)......April 30 Third Quarter (Jul - Sep).....October 31 Second Quarter (Apr - Jun)......July 31 Fourth Quarter (Oct - Dec).....Use WH-1606

Do not use WH-1605 to file your fourth quarter return. Use WH-1606 for fourth quarter.

You must file a return even if no SC Income Tax has been withheld during the quarter. You must file a WH-1606 if the account was open for any portion of the calendar year.

Quarterly SC Income Tax information:

- Line 1 Enter total quarterly SC Income Tax withheld from all sources. Enter corrected amount if filing an amended return.
- Line 2 Enter total quarterly SC Income Tax deposits or payments previously made. For amended return, include amount paid with original WH-1605.
- Line 3 If line 2 is greater than line 1, enter the amount of refund. Skip lines 4-6.
- Line 4 If line 2 is less than line 1, enter the amount of tax due.
- Line 5 Enter the amount of penalty and interest due if applicable. Visit **MyDORWAY.dor.sc.gov** for a penalty and interest calculator.
- Line 6 Enter the net SC Income Tax, penalty, and interest due.

To avoid delays in processing your return:

- Amounts withheld from employees on W2s cannot be refunded to employers.
- Use black ink only.
- Do not staple attachments.
- Write all numbers clearly. Always include cents. (examples: 20.13, 19.00)
- Do not put slashes, dashes, dollar signs, or commas on the amount lines.
- Sign the return. The signature must be from a person authorized to act on behalf of withholding agent.
- Sign your check and include the written dollar amount.
- Attach payment for the full amount due to this return. Do not include a WH-1601 coupon.
- · Mail to the correct address.

 - Refunds or zero tax: SCDOR, Withholding, PO Box 125, Columbia, SC 29214-0004

Authorization and signature:

Check the box for release of confidential information and provide the preparer's name and phone number. This authorizes the Director of the SCDOR or delegate to discuss **this** return, its attachments, any notices, adjustments or assessments with the preparer.
