**Purpose**

If you are applying for an extension of time to file your 2020 North Dakota individual income tax return, you may make an extension payment to prepay the tax that you expect to owe to avoid paying extension interest.

If you make an extension payment, you must file Form ND-1 and claim the payment on page 2, line 27.

The payment must be made no later than April 15, 2021 to avoid extension interest.

**Important.** Do not use this voucher if you:

- Choose to make the payment electronically—see “How to make payment” for your payment options.
- File your return on or before April 15, 2021.
- Pay your balance due after April 15, 2021.

If you file your return after April 15, 2021, any tax paid with the return is subject to extension interest.

**How to make payment**

If paying by check or money order, make the check or money order payable to “ND State Tax Commissioner,” and write last four digits of social security number(s) and “2020 ND-1EXT” on check or money order. Complete the payment voucher below, detach it from this page, and mail it with the check or money order to:

Only a check drawn on a U.S. or Canadian bank in U.S. dollars and using a standard 9-digit routing number is accepted.

**Electronic payment option.** Instead of paying by check or money order with this payment voucher, the payment may be made online with an electronic check or a debit or credit card. The electronic check option is free. North Dakota contracts with a national payment service to provide the debit or credit card option, for which there is a fee, none of which

goes to the State of North Dakota. *If paying electronically, do not use this voucher.*
