- **7. Total Local Option Sales Tax:** Complete the schedule on the opposite side if you made sales into a local option jurisdiction. Sales should be reported on a county-by-county basis.
- 9. SSTP Allowance: Formulas are not yet established; therefore, the allowance cannot be claimed at this time.
- 13. Penalty: Penalties can only be waived under limited circumstances, as described in Iowa Code section 421.27.

Failure to Timely File a Return: A penalty of 10% will be added to the tax due for failure to timely file a return if the return is filed after the original due date of the return and if at least 90% of the correct amount of tax is not paid by the original due date of the return.

Failure to Timely Pay the Tax Due or Penalty for Audit Deficiency: A penalty of 5% will be added to the tax due if the return is filed by the original due date and at least 90% of the correct amount of tax is not paid by the original due date of the return.

When the failure to file penalty and the failure to pay penalty are both applicable, only the failure to file penalty will apply.

Penalty for Willful Failure to File: A penalty of 75% will be added to the tax due for willful failure to file a return or for filing with intent to evade tax.

**14. Interest:** Any fraction of a month is considered as a whole month. Interest accrues on the unpaid tax from the due date of the return. Check our website for rates. Interest cannot be waived.

**Due Date:** Streamlined returns are due on the 20th of the month following the end of the filing period. If the due date falls on a weekend or holiday, it is due the following business day.

**Payment** of any balance due may be paid by ACH Credit through your financial institution or by check. Make checks payable to Treasurer-State of Iowa. When you pay by check, you authorize the Department of Revenue to convert your check to a one-time electronic banking transaction.

### **Exemptions Instructions**

Exemptions are sales made by you on which tax was not required to be charged. Enter your exemptions for the entire period on this return.

- **a. Interstate Commerce:** Sales where delivery occurred outside lowa.
- **b. New Construction:** Sales of services performed on or in connection with new construction, reconstruction, alteration, expansion, or remodeling of a building or structure.
