2022 School District Estimated Income Tax Instructions

Do I Have To Make Estimated Payments?

If your income is subject to school district withholding, you generally do not need to make estimated payments. You should make estimated payments for tax year 2022 if your estimated school district tax liability (total tax minus total credits) less school district withholding is more than \$500. Individuals generally must make estimated payments if they are:

- Employees who are under-withheld by their employers;
- Retirees without school district tax withholding from their pensions.
- Pass-through entity investors or sole proprietors; AND/OR
- Individuals with large amounts of investment income.

Estimated payments are due as follows:

1st quarter - April 18, 2022 2nd quarter - June 15, 2022 3rd quarter - Sept. 15, 2022 4th quarter - Jan. 17, 2023

Use the Ohio SD 100ES vouchers to make estimated school district income tax payments. Joint filers should determine their combined estimated school district tax liability and make joint estimated payments. See information release IT 2006-01 titled "Estimated Payment Allocation Process" at **tax.ohio.gov**.

Note: Instead of making estimated payments, you can increase your Ohio withholding by filing a revised Ohio IT 4 with your employer. Also, special rules regarding estimated payments apply to certain taxpayers with farming and/or fishing income. See Adm. Code 5703-7-04.

If you do not make the required estimated payments, you may be subject to an interest penalty for underpayment of estimated taxes. See form IT/SD 2210.

What Are My Payment Options?

Once you have calculated your estimated payments, you must pay them quarterly through any of the following methods:

- Online Pay via electronic check, debit card or credit card using the Department's Online Services or Guest Payment Service at tax.ohio.gov/pay.
- By Phone Pay by credit or debit card by calling ACI Payments at 1-800-272-9829 (1-800-750-0750 for persons who use text telephones (TTYs) or adaptive telephone equipment). The Ohio jurisdiction code is 6446. ACI Payments charges a convenience fee equal to 2.5% of your payment or \$1, whichever is greater. The state of Ohio does not receive any of this fee.
- By Mail Send a check or money order with the appropriate payment voucher. Make the payment payable to "Ohio Treasurer of State."

School District Income Tax Base

Taxing school districts use one of the following two tax bases:

The **traditional tax base** uses modified adjusted gross income to calculate the tax base. Refer to lines 19-23 of the 2021 SD 100 to assist you in estimating this tax base.

The **earned income tax base** uses "earned income" to calculate the tax base. Refer to lines 24-27 of the 2021 SD 100 to assist you in estimating this tax base.
