## PA CORPORATION SPECIALTY TAXES EXTENSION COUPON

**You must timely file REV-426 even if you are not making a payment with the extension request.**

- Enter account information** including file period begin, file period end, Revenue ID, due date, entity name, EIN and complete mailing address.
- Enter payment(s) required** for the appropriate tax type(s) from the list below. Find the three-digit code next to the appropriate tax type and enter it in one of the three boxes to the right. The code will populate into the tax type box on the attached coupon. You may use this coupon to pay up to three tax types with the same file period. Use only one code per box. Be careful when making your selection(s) to ensure your payment(s) is applied to the correct tax type.
- Payments of \$1,000 or more** must be made electronically or by certified or cashier's check remitted in person or by express mail courier. Electronic payments can be made through myPATH. Visit [mypath.pa.gov](http://mypath.pa.gov) to register for an account. If

paying by certified or cashier's check, make it payable to PA Department of Revenue and deliver check and coupon to:
