Section A: BUSINESS INFORMATION

- 3. Provide your Federal Employer Identification No. (FEIN) or Social Security No. (SSN) if you are a sole proprietor without employees. Taxpayers are required to provide their taxpayer identification number (TIN) on all returns and documents. - 11. Provide the filing frequency. If your total estimated annual combined Arizona, county and municipal TPT liability is:
 - Less than \$2,000, you may file and pay annually.
 - Between \$2,000 and \$8,000, you may file and pay quarterly.
 - Otherwise, your transaction privilege taxes are due monthly.
