Do not use dollar signs, commas, or other punction marks.





## **Printing**



Set page scaling to "none." The Auto-Rotate and Center checkbox should be unchecked.



Do not select "print on both sides of paper."



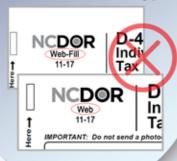
# **Before** Sending
