^{**}In the event that the nonrefundable credit is not fully utilized, the excess shall be refunded to the taxpayer. However, if any amount of the credit is refunded, the sum of the amount refunded and the amount applied to reduce the tax otherwise due for that year shall not exceed \$3 million. The taxpayer may then carry forward any excess balance for not more than five calendar years.
