

PERSONAL INCOME TAX CHANGE OF ADDRESS FORM

PURPOSE OF THIS FORM: Individuals may use Form RPD-41260, *Personal Income Tax Change of Address Form*, to notify the Taxation and Revenue Department of a change in address.

HOW TO COMPLETE THIS FORM: Enter the effective date of change. Enter your name and social security number. If married, also enter your spouse's name and social security number. Enter a prior name if you or your spouse's name has changed since last filing. Enter both your previous and new home address. Be sure to include any apartment numbers. You and your spouse (if applicable) must sign and date the form.

Mail this form to the Taxation and Revenue Department, P O Box 25122, Santa Fe, New Mexico 87504-5122. For assistance call your local district office (see back of page for listing).

If you wish to change your business address, use Form ACD-31015, *Business Tax Registration Application and Update*. If you wish to change your address with the Motor Vehicle Division, please complete Form MVD-10284, *Change of Address Request*. These forms are available on the Department's internet site and at your local district office (see back of this form for details).
