A business entity that files a single Arizona income tax return which includes income from more than one transaction privilege tax license may file this election form with the Arizona Department of Revenue if it is expected that the credit for accounting and reporting expenses for all transaction privilege tax licenses will meet or exceed the maximum amount for the calendar year. This election form should indicate how the credit will be allocated among the licensees. The credit is claimed on Arizona Form TPT-2. See A.R.S. § 42-5017 for additional information and requirements to claim the accounting credit.

Allocating the credit: List all Arizona transaction privilege tax (TPT) licenses that are part of this group and are subject to the election. All TPT licensees who file a TPT return are eligible for a credit of up to \$10,000. TPT licensees who file all their TPT returns electronically for the entire calendar year may claim an additional credit of up to \$2,000. Use whole dollar amounts to indicate the amount of each election. If TPT returns for all licenses are filed electronically, check this box.
