To request copies of your Montana tax information, fill out all the applicable fields below, sign, and attach the required information. If you are requesting this information on behalf of another taxpayer, you must provide a Power of Attorney Authorization to Disclose Information (Form POA) from the taxpayer. Form POA is available at [revenue.mt.gov](http://revenue.mt.gov) or on the TransAction Portal (TAP) at <https://tap.dor.mt.gov>.

### Information Requested

Forms W-2, Forms 1099, or Forms 1098, includes data from these information returns, Montana state information will be included. If you need a copy of these forms, you should first contact the payer. Note that current year information may not be available until six months after the filing period.

Tax Return(s): includes most line items on the Montana Individual Income Tax Return (Form 2). Note that current year information may not be available until six months after the filing period.

Include all schedules and supplements.

Account Status: includes information on the financial status of the account, such as payments made on the account and penalty and interest assessments. Return information is limited to items such as a tax liability, estimated payments, and refundable credit amounts.

Verification of Nonfiling, requesting a letter that confirms that you did not file a return in Montana for the year.
