Do not use red ink. Use blue or black ink.



Do not use dollar signs, commas, or other punctuation marks.



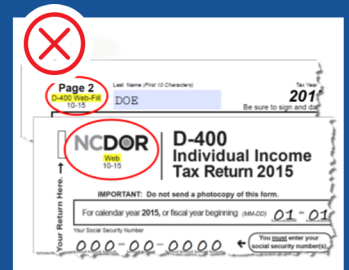
Before You Send



Do not submit photocopies of returns. Submit originals only.



Do not mix form types



Printing



Set page scaling to "none." The Auto-Rotate and Center checkbox should be unchecked.



Do not select "print on both sides of paper."



D-410P Application for Extension for Filing Partnership, Estate, or Trust Tax Return

General Instructions

Purpose - Use Form D-410P to request a six (6) month extension to file either the Partnership Income Tax Return (Form D-403) or the Estates and Trusts Income Tax Return (Form D-407). The extension will be granted if Form D-410P is properly filed by the due date of the return for which the extension is requested.

If a partnership, estate, or trust is granted an automatic extension to file its federal income tax return, the entity does not have to file Form D-410P to receive an extension of time to file Form D-403 or Form D-407. However, an extension of time to file Form D-403 or Form D-407 does not extend the time to pay the amount of tax due.

Specific Instructions

Demographic Information - In the space provided, enter the entity's federal employer identification number, name, and address. **Important:** Be sure to fill in the circle that matches the entity type for which the extension is requested.

Line 1 - Enter the total tax the entity expects to owe for the year. If the entity expects this amount to be zero, leave Line 1 blank.

Line 2 - Enter the total amount of payments and tax credits the entity expects to claim for the tax year.

Line 3 - Subtract Line 2 from Line 1. **Important:** If there is a balance due, the entity must remit any unpaid tax by the due date of the return for which the extension is requested to avoid interest and the failure to pay penalty on the unpaid tax.

The entity can request an extension and pay any tax due online. For details, visit ncdor.gov, select "File and Pay," then, under "Tax Category" select "Estates and Trusts" or "Partnership Tax."
